## Aims of the Summit and the European Biosafety Network

The 2nd European Biosafety Summit will be held on 1 June 2011, one year after the 1st European Biosafety Summit was held in Madrid when the European Sharps Directive was published, which implemented the EU Framework Agreement negotiated between the EU social partners EPSU and HOSPEEM. The Summit will also coincide with European Biosafety Day. The Summit will highlight the risks, impact and raise awareness of sharps injuries and report on progress within the Member States and across Europe towards implementation of the Sharps Directive and its transposition into national legislation.

The Summit will also discuss components of a practical toolkit for implementation and will be presented with a Blueprint for Action drafted by the European Biosafety Network. The European Biosafety Network was established in 2010 as a virtual network of national and European professional institutions, representative associations, unions and other interested organisations committed to the elimination of sharps injuries throughout the EU and to improve the safety of patients and healthcare and non-healthcare workers. This will be achieved by increasing the education and training of healthcare and non-healthcare workers, promoting best and safer practice and providing safety engineered technologies. A Toolkit for the implementation of the Sharps Directive will be launched at the Summit.
